3. Non marking footwear to be worn at all times.
4. All players are expected to observe the standard of dress code for any racket sport and appear neat, clean and tidy on the court!
5. No wet or muddy shoes allowed on the court surface.
6. Players and umpire only to be on court area. All others to stay behind marked line for safety reasons. Parents are kindly requested to stay off court during Juniors coaching sessions unless required by the coach. To maximise Juniors Court time, no other players or members are permitted to use courts during the coaching sessions.
7. All playing equipment to be properly maintained and in a good playing condition.
8. We accept no responsibility for any persons or activities outside the badminton hall.
9. No food, drink or chewing gum allowed on the courts.
